The Onondaga County Resource Recovery Agency operates these Yard Waste Sites on a non-profit basis. This annual Compost Pass is for residential use only and the terms below relate to the owner of a single residential unit. In order to avoid expensive insurance costs, we require users to accept certain responsibilities below:

SITE USE AND TERMS FOR YARD WASTE DROP OFF & COMPOST/MULCH PICK UP

I, _____, (Please Print Name), have requested to enter the Onondaga County Resource Recovery Agency Yard Waste Composting Site ("Site") to **drop off an unlimited volume of yard waste** and/or to **take up to six (6) cubic yards of Compost/Mulch** on the following terms:

- I represent that the yard waste I am dropping off contains no hazardous contaminants. If it does, I will be responsible for any consequential contamination to the Site or to compost/mulch at the OCRRA Site.
- I agree to use the compost/mulch I receive only on property owned by me and over which I have full authority.
- I agree to accept full and sole responsibility for any and all damages or injuries to myself, my family or guests, my vehicle, or my property incurred during my presence on the Site; or caused by me during the drop off of my yard waste or the picking up or loading by OCRRA personnel; or utilization of the compost/mulch; and will in no way hold the Onondaga County Resource Recovery Agency or the County of Onondaga responsible for any consequences from my activities while on the Site or from the loading by OCRRA personnel or my use of said compost/mulch. I agree not to bring any legal action against the Agency related to the quality, condition, or use of the compost/mulch and if any such action is brought I will accept full responsibility, financial and otherwise, for it and hold the Agency harmless. I also agree to defend and hold the Agency harmless from any injuries or damages caused by the use of my vehicle on Site or by my activities while on Site.
- I recognize that compost/mulch contains spores, fungus and other substances that may cause allergic or other reactions and I will assume all risks for exposure to such substances and will hold the Onondaga County Resource Recovery Agency and Onondaga County harmless and assume all risks for any injury resulting therefrom.
- I agree to accept this compost/mulch "as is" and understand that OCRRA makes absolutely no warranties or representations related to its quality, use or fitness for any purpose whatsoever or other warranties of any kind.

I have carefully read all of the above terms and conditions before dropping off any yard waste and/or accepting any compost/mulch and agree to be bound by them.
